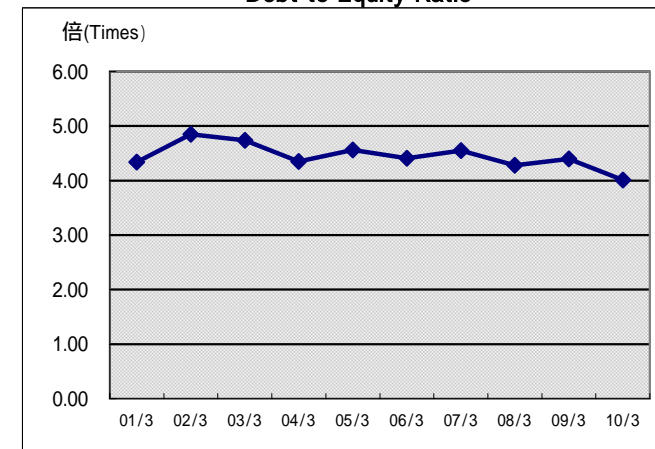

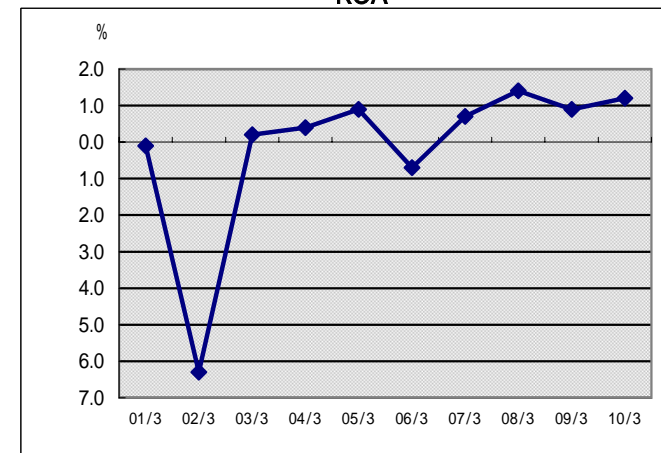
**売上高営業利益率**

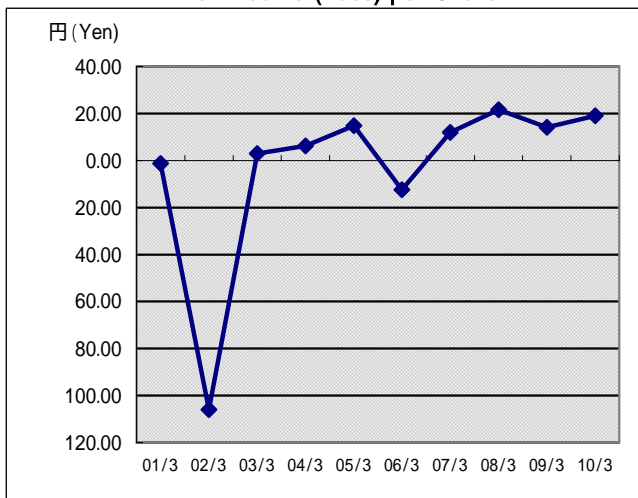

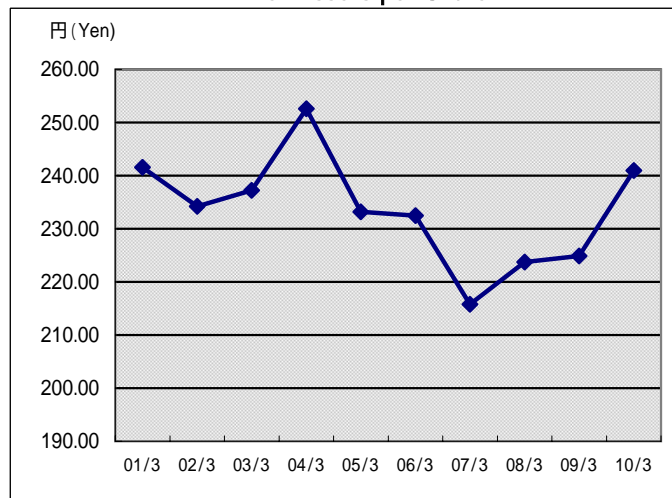

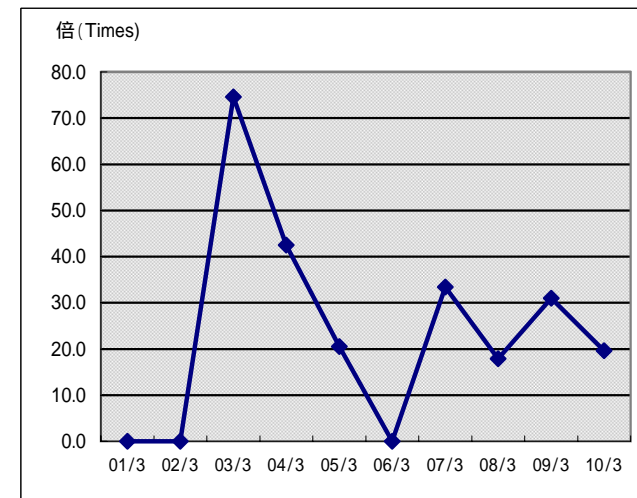
一株当たり当期純利益(損失)

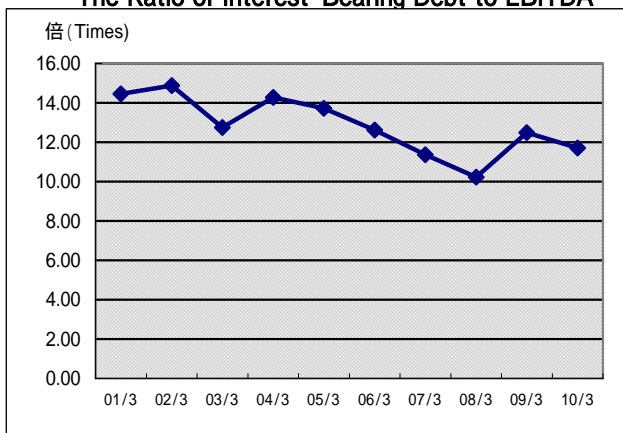

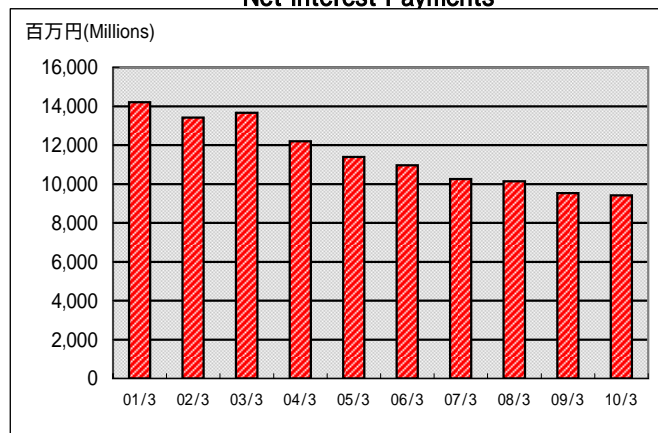

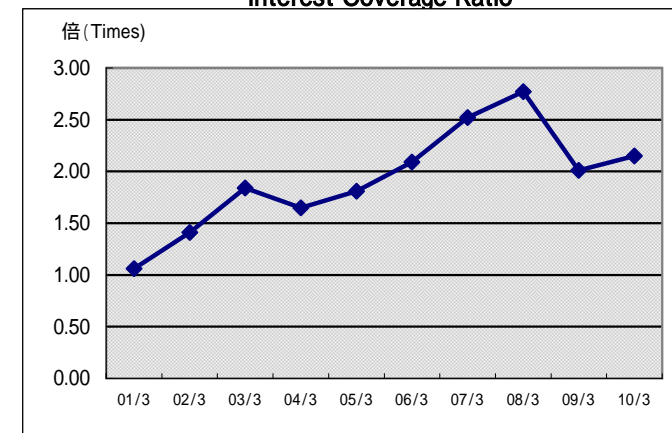
**有利子負債EBITDA倍率**

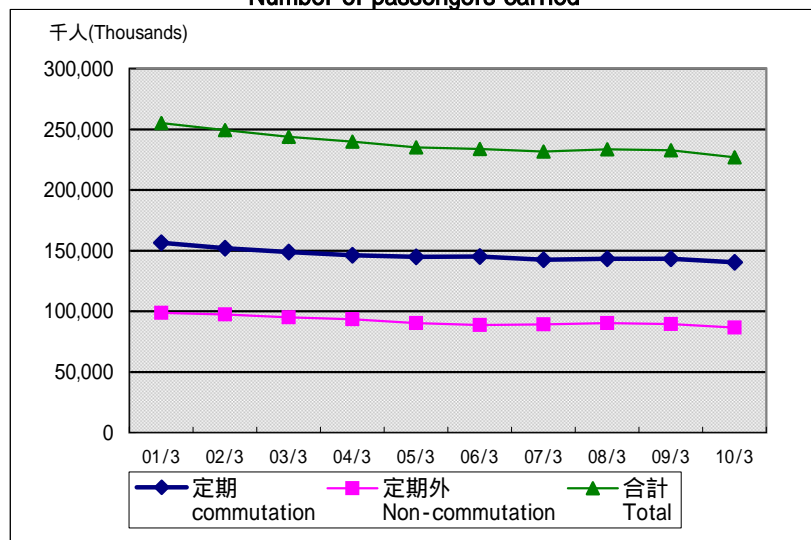
